INTRODUCTION

The purpose of this circular is to provide you with information in relation to the resolutions to be proposed at the AGM, among other matters, (i) the granting of the General Mandate to the Directors; (ii) the re-election of Directors; and (iii) the change of auditors.

GENERAL MANDATE

At the AGM, an ordinary resolution will be proposed that the Directors be given an unconditional general mandate to allot, issue and deal with unissued Shares or securities convertible into Shares, options, warrants or similar rights to subscribe for any Shares (other than by way of rights or pursuant to a share option scheme for employees of the Company or Directors and/or any of its subsidiaries or pursuant to any scrip dividend scheme or similar arrangements providing for the allotment and issue of Shares in lieu of whole or part of the dividend on Shares in accordance with the Articles of Association or upon the exercise of rights of subscription or conversion under the terms of any securities or bonds convertible into Shares) or make or grant offers, agreements, options and warrants which might require the exercise of such power, of an aggregate nominal amount of up to 20% of the aggregate nominal amount of the issued Shares as at the date of granting the general mandate.

LETTER FROM THE BOARD

As at the Latest Practicable Date, the Company had 131,973,638 Shares in issue. Subject to the passing of the resolution for the approval of the General Mandate and on the basis that no further Shares are issued or repurchased between the Latest Practicable Date and the date of the AGM, the Company would be allowed under the General Mandate to allot, issue and deal with a maximum of 26,394,727 Shares.

The General Mandate shall continue to be in force during the period from the date of passing of the resolutions for the approval of the General Mandate up to (i) the conclusion of the next annual general meeting of the Company; (ii) the expiration of the period within which the next annual general meeting of the Company is required by the Articles of Association, or any other applicable laws of Hong Kong to be held; or (iii) the passing of an ordinary resolution by the shareholders of the Company in general meeting revoking or varying the authority given to the Directors, whichever occurs first.

The Directors have no immediate plans to issue any new Shares.

RE-ELECTION OF DIRECTORS

According to Articles 81 and 83 of the Articles of Association, at every annual general meeting one-third of the Directors for the time being or, if their number is not a multiple of three, then the nearest number to but not less than one-third shall retire from office by rotation provided that every Director shall be subject to retirement by rotation at least once every three years. A retiring Director shall be eligible for re-election. Accordingly, each of Madam Huang Haiping, Madam Song Xiaoling and Mr. Wong Cheong will retire from his office by rotation at the AGM and, being eligible, each of them will offer herself/himself for re-election.

Particulars relating to Madam Huang Haiping, Madam Song Xiaoling and Mr. Wong Cheong are set out in the Appendix to this circular.

CHANGE OF AUDITORS

The Board announces that Deloitte, the Company's auditors, have resigned as auditors of the Group with effect from 6th May, 2011, as the Board and Deloitte could not reach a consensus on the audit fees for the year ending 31 January 2012. The Board has accepted the resignation of Deloitte solely for audit fee competitiveness reason, which is in line with the Company's policy to control and reduce the cost of operation.

Deloitte have completed the audit on the financial statements of the Company and of the Group for the year ended 31 January 2011 and have not yet commenced any audit work for the financial year ending 31 January 2012. Deloitte confirmed that there are no circumstances connected with their resignation which they considered should be brought to the attention of the shareholders and creditors of the Company.

The Board has resolved to propose the appointment of Crowe Horwath as the auditor of the Group for the year ending 31 January 2012 to fill the casual vacancy arising from the resignation of Deloitte, which is subject to approval by the shareholders of the Company at the 2011 AGM.

LETTER FROM THE BOARD

Both the Board and the audit committee of the Company were not aware of any matter in respect of the resignation of Deloitte as the Company's auditors that should be brought to the attention of the shareholders and creditors of the Company.

AGM

A notice convening the AGM to be held at the Meeting Room of Island Pacific Hotel at 152 Connaught Road West, Hong Kong on Friday, 10th June, 2011 at 11:00 a.m. is set out on pages 9 to 11 of this circular. Ordinary resolution will be proposed at the AGM to approve the proposed grant of the General Mandate.

A form of proxy for use at the AGM is enclosed with this circular. Such form of proxy is also published on the designated website of the Stock Exchange (www.hkexnews.hk) and on the website of the Company (www.capitalfp.com.hk/eng/index.jsp?co=108). Whether or not you are able to attend the AGM, you are requested to complete the accompanying form of proxy in accordance with the instructions printed thereon and deposit the same at the share registrar of the Company, Tricor Standard Limited at 26th Floor, Tesbury Centre, 28 Queen's Road East, Wanchai, Hong Kong as soon as possible and in any event not less than 48 hours before the time appointed for the holding of the AGM or any adjournment thereof. Completion and return of the form of proxy will not preclude you from attending and voting in person at the AGM or any adjournment thereof should you so wish.

RECOMMENDATION

The Directors believe that the proposed grant of the General Mandate, the proposed re-election of Directors and the proposed change of auditors are in the best interests of the Company and the Shareholders as a whole and recommend the Shareholders to vote in favour of all the resolutions to be proposed at the AGM.

The Directors believe that an exercise of the General Mandate to allot and issue new Shares will enable the Company to take advantage of market conditions to raise additional capital for the Company.

The details of the Directors who will retire from office at the AGM and being eligible, will offer themselves for re-election at the AGM, are set out below:

Executive Directors

Madam Huang Haiping, aged 59, appointed as an executive Director and the Chief Executive Officer of the Company on 1st February, 2007, is also acting as the chairman of the Company's remuneration committee. She also acts as directors of Jiacheng (Fujian) Investments Co., Ltd. and Vast Glory (Fujian) Hotel Management Limited, both of which are wholly-owned subsidiaries of the Company. Madam Huang graduated from the Department of Chemical Engineering of Zhejiang University, the PRC, and was designated as engineer and senior economist in 1987 and 2003 respectively. Madam Huang was a cadre member of the Science and Technology Commission of Fuzhou Municipal People's Government and construction design and budgetary estimate personnel of the Fujian Petrochemical Engineering Design Institute. Prior to joining the Company, she worked as deputy general manager of the head office's business department of Industrial Bank. Madam Huang is vastly experienced in construction design, budgetary estimate, finance and administration. Save as disclosed herein, Madam Huang did not hold in the past three years any directorship in other public companies the securities of which are listed on any securities market in Hong Kong or overseas.

Madam Huang's appointment as an executive Director does not have a specific term, and there is no service contract entered into between the Company and Madam Huang. The amount of director's emoluments for Madam Huang is HK\$29,000 per month. Such emoluments have been made with reference to her duties, responsibilities and contribution to the Group. Save as disclosed herein, except the director's emoluments, there are no other benefits provided to Madam Huang for her directorship in the Group.

Madam Huang does not have any relationship with any other Directors, senior management, substantial shareholders or controlling shareholders of the Company within the meaning of the Listing Rules. As at the Latest Practicable Date, Madam Huang does not have, and is not deemed to have, any interests or short positions in any Shares, underlying Shares or debentures of the Company within the meaning of Part XV of the SFO.

There is no information relating to Madam Huang that is required to be disclosed pursuant to Rule 13.51(2)(h) to (v) of the Listing Rules.

Save as disclosed herein, there is no other matter of Madam Huang that needs to be brought to the attention of the Shareholders and the Stock Exchange.

Madam Song Xiaoling, aged 58, appointed as an executive Director on 24th October, 2008, also acts as a director of Vast Glory (Fujian) Hotel Management Limited, a wholly-owned subsidiary of the Company. Madam Song was born at Laiyang County, Shandong Province, the PRC and graduated from the Faculty of Chinese at Xiamen University in the PRC in 1976. Upon graduation, she worked in the Office of Fujian Provincial People's Government in the PRC as secretary and later a section chief. In 1987, Madam Song joined Fuzhou Lakeside Hotel ("Hotel") in the PRC as Manageress of the Personnel Training Department, and then she was in 1991 promoted to Deputy General Manageress of the Hotel and to Party Committee Secretary and Deputy General Manageress of the Hotel concurrently in 1995. She was the Principal of Technical School of Fuzhou Lakeside Hotel in the PRC concurrently during the period from 1992 to 2001. During the period from 2001 to 2005, she acted as the General Manageress of Fuzhou Lakeside Hotel Management Company Limited in the PRC concurrently. Madam Song is vastly experienced in the management and personnel training of hotels. Save as disclosed herein, Madam Song did not hold in the past three years any directorship in other public companies the securities of which are listed on any securities market in Hong Kong or overseas.

Madam Song's appointment as an executive Director does not have a specific term, and there is no service contract entered into between the Company and Madam Song. The amount of director's emoluments for Madam Song is HK\$24,000 per month. Such emoluments have been made with reference to her duties, responsibilities and contribution to the Group. Save as disclosed herein, except the director's emoluments, there are no other benefits provided to Madam Song for her directorships in the Group.

Madam Song does not have any relationship with any other Directors, senior management, substantial shareholders or controlling shareholders of the Company within the meaning of the Listing Rules. As at the Latest Practicable Date, Madam Song does not have, and is not deemed to have, any interests or short positions in any Shares, underlying Shares or debentures of the Company with the meaning of Part XV of the SFO.

There is no information relating to Madam Song that is required to be disclosed pursuant to Rule 13.51(2)(h) to (v) of the Listing Rules.

Save as disclosed herein, there is no other matter of Madam Song that needs to be brought to the attention of the Shareholders and the Stock Exchange.

Independent non-executive Directors

Mr. Wong Cheong, aged 56, appointed as an independent non-executive Director on 20th October, 2006, is also a member of the Company's audit committee and nomination committee respectively. Mr. Wong has been serving as engineer of several companies in Macau for over 15 years. Mr. Wong is currently director and shareholder of two companies, namely International Elevator Engineering Company Limited and Weng Cheong Kong Cheng Kong Si, which engage in construction engineering and lifts installation in Macau. Mr. Wong has extensive experience in the areas of construction engineering and property repair, maintenance and management. Save as disclosed herein, Mr. Wong does not hold any position with the Company or other members of the Group and he did not hold in the past three years any directorship in other public companies the securities of which are listed on any securities market in Hong Kong or overseas.

Mr. Wong's appointment as an independent non-executive Director does not have a specific term, and there is no service contract entered into between the Company and Mr. Wong. The amount of director's emoluments for Mr. Wong is HK\$10,000 per month. Such emoluments have been determined based on the estimated time to be spent by him on the Company's matters, as well as his contribution of efforts and expertise. Save as disclosed herein, except the director's emoluments, there are no other benefits provided to Mr. Wong for his directorship in the Company.

Mr. Wong does not have any relationship with any other Directors, senior management, substantial shareholders or controlling shareholders of the Company within the meaning of the Listing Rules. As at the Latest Practicable Date, he does not have, and is not deemed to have, any interests or short positions in any Shares, underlying Shares or debentures of the Company within the meaning of Part XV of the SFO.

There is no information relating to Mr. Wong that is required to be disclosed pursuant to Rule 13.51(2)(h) to (v) of the Listing Rules.
